The Company is a Tuition Centre which provides educational services to adults. The Company must process personal data (including sensitive personal data) so that it can provide these services – in doing so, the Company acts as a data controller.

You may give your personal details to the Company directly, such as on an application or registration form or via our website, or we may collect them from another source such as the Job Centre. The Company must have a legal basis for processing your personal data. For the purposes of providing you with work-finding services and/or information relating to roles relevant to you we will only use your personal data in accordance with the terms of the following statement.

1. Collection and use of personal data

a. Purpose of processing and legal basis

The Company has collected your personal data (which may include sensitive personal data) and will process your personal data for the purposes of providing you with educational services. The legal bases we rely upon to offer these services to you are:

- **Consent** We may use your personal information to contact you for learning opportunities.
- Legitimate interest To be able to enrol you on the courses you have applied for
- Legal obligation To comply with our legal and regulatory obligations

b. Categories of data

The Company may collect the following personal data on you:

- Health Declaration
- Suitable Persons Declaration
- Disqualification for Caring for Children
- Children's and Vulnerable Adults' Barred List Details

c. Legitimate interest

Where the Company has relied on a legitimate interest to process your personal data our legitimate interests is/are as follows:

• To act as an educational business which provides educational services to learners

d. Recipient/s of data

The Company will process your personal data and/or sensitive personal data with the following recipients:

- Laser Learning e-portfolio
- LearnerTrack (for ESFA funded courses)
- Ncfe CACHE
- Home Office (where Visa checks are applicable)
- Job Centre (where applicable)
- Infinity SaS (our internal database)

2. Data retention

The Company will retain your personal data only for as long as is necessary. Certain laws may require us to keep some of the data for different periods of time.

Educate 2Gether will keep learners records on their internal database for at least one year from (a) the date of their creation or (b) after the date on which we last provide you with educational services.

Laser Learning e-portfolio will store all portfolio content for 7 years calculated from the learner end date added to the system.

Where the Company has obtained your consent to process your personal data for the purpose of contacting you for learning opportunities, we will do so for 1 year. Upon expiry of that period the Company will seek further consent from you. Where consent is not granted the Company will cease to process your data.

3. Your rights

Please be aware that you have the following data protection rights:

- The right to be informed about the personal data the Company processes on you;
- The right of access to the personal data the Company processes on you;
- The right to rectification of your personal data;

- The right to erasure of your personal data in certain circumstances;
- The right to restrict processing of your personal data;
- The right to data portability in certain circumstances;
- The right to object to the processing of your personal data that was based on a public or legitimate interest;
- The right not to be subjected to automated decision making and profiling; and
- The right to withdraw consent at any time.
